Adamstown Public School is committed to providing a technology-rich environment for our students. Our school community considers the use of Information and Communication Technology (ICT) fundamental in assisting teaching and learning in all areas of the school curriculum in addition to using technology as a tool for communication.

The school uses third-party providers offering cloud-based storage to support our administrative functions and enhance student learning outcomes. The department has a service agreement with some providers it has assessed as meeting privacy and security standards required of the department. The school offers students access to other services in addition to these. Adamstown Public School has used the Seesaw App for several years to engage our community with student learning and communication. Registration to Seesaw is through a subscription paid by the school, entering only the schools identifying information such as address and email address. When forming classes on Seesaw we enter the child's name as part of the grouping process, no student identifying information or individual email addresses are provided.
